BILL HODGETTS, PHD - PRESIDENT

University of Alberta - Edmonton, AB

Bill Hodgetts is an associate professor in the Department of Speech Pathology and Audiology at the University of Alberta. He holds a joint appointment at the Institute for Reconstructive Sciences in Medicine (iRSM) where he is program director for audiology and bone conduction amplification (BCA). He obtained his B.A. (Psychology) and M.Sc. (Audiology) from the University of Western Ontario and his Ph.D. (Rehab Sciences) from the University of Alberta. Bill teaches Audiology/Hearing Science as well as Statistics and Research Design at the U of A. His research focuses on the assessment, prescription, verification and validation of bone anchored amplification devices with a goal of improving outcomes for BCA users and transferring knowledge to other clinicians involved in BCA.

MARLENE BAGATTO - PRESIDENT-ELECT

Western University - London, ON

Marlene Bagatto, Au.D., Ph.D. is a Research Associate and Adjunct Research Professor at the National Centre for Audiology at Western University in London, Ontario. Her research interests have a clinical focus and relate to fitting hearing aids to the pediatric population. She led the development, evaluation and implementation of a system for monitoring functional outcomes for infants, toddlers and preschool children who wear hearing aids. In addition, Dr. Bagatto serves as an Amplification Consultant for the Ontario Ministry of Children and Youth Services' Infant Hearing Program where protocol development, implementation and monitoring are her main activities. Dr. Bagatto also provides clinical services to infants involved in the Ontario Infant Hearing Program at the H.A. Leeper Speech and Hearing Clinic at Western.

GURJIT SINGH, PHD - PAST PRESIDENT

Gurjit Singh, PhD, Reg. CASLPO is a Senior Research Audiologist and Program Manager at Phonak AG in Switzerland, the largest manufacturer of hearing loss rehabilitation technologies (e.g., hearing aids, cochlear implants, etc) in the world. He works in the long-term research division of the company and is based in Toronto, Canada. In addition to holding Adjunct Professor status in the Department of Psychology at Ryerson University, he also holds Adjunct status at the University of Toronto and the Toronto Rehabilitation Institute. He is also a clinical audiologist (Reg. CASLPO) and the current Past-President of the Canadian Academy of Audiology. Broadly, he is interested in factors that contribute to success with audiologic rehabilitation. His projects focus on the audiologic consequences of listening to signals that contain or evoke emotional responses, the role of cognition in hearing, emerging technologies (e.g., internet technologies), and factors that contribute to judgment and decision-making in patients and practitioners. Dr. Singh completed a postdoctoral fellowship at the Toronto Rehabilitation Institute that focused on teleaudiology, a PhD (Cognitive Psychology) from the University of Toronto where his research focused on the role of attention in speech understanding, an M.Sc. (Audiology) from the University of Western Ontario, and an M.A. (Social Psychology) from the University of Waterloo.

SALIMA JIWANI - SECRETARY

AudioSense - Hearing & Balance Centre - Toronto, ON

Salima Jiwani is the clinical and research Director of Audiology at AudioSense Inc., a centre of excellence in Hearing and Balance Healthcare. Salima earned her Ph.D. in auditory neurophysiology with the Institute of Medical Science at the University of Toronto. She completed her doctoral work at the Cochlear Implant Lab at the Hospital for Sick Children in Toronto, where she worked with children and adolescents who are deaf and have used a cochlear implant to hear for most of their lives. During her Ph.D., she developed novel imaging techniques to map the brain network that is activated by sound in cochlear implant users over the long-term. She has also worked extensively with children who have Auditory Neuropathy Spectrum Disorder during her research.

Prior to this, she received her Audiology degree from Dalhousie University, where she completed a Master's thesis concurrently with a clinical degree, where she investigated methods to diagnose Vestibular Schwannomas more reliably. In the clinic, Salima has worked as a Clinical Territory Manager with Cochlear Canada Inc., providing support to clinicians and researchers who work with cochlear implants and bone anchored hearing devices. Salima has experience working with both an adult and pediatric population, through her work experience at the Cochlear Canada Inc., the Hospital for Sick Children and the Centenary Community Hospital. Salima has always been interested in working with people suffering from auditory challenges, to help them perform better in a hearing world. Outside of work hours, she is an advocate for the profession of audiology as an Executive on the Board of the Canadian Academy of Audiology and co-chair of the Science and Education Committee. In this role, she encourages clinical research in the field of audiology and use of an evidence-based approach for all clinical work and a translational approach to research to promote optimal hearing health care.
