

The Clinical Audiologist, BCEHP provides clinical assessment and treatment services utilizing advanced knowledge and expertise in the area of diagnostic audiology testing of infants and young children. Acts as a clinical resource by providing clinical advice, guidance and support services on complex cases to Audiologists throughout the province. Develops education programs/material and clinical quality improvement process, conducts formal training and education, communicates updates to protocols, and evaluates effectiveness of education and training materials to ensure consistent standards and evidence-based practice. This position facilitates, as part of the Diagnostic Assessment Clinical Quality Improvement Panel, the ongoing review and revision of the BCEHP Diagnostic Audiology Protocols. Initiates and participates in research activities and facilitates the research culture

Qualifications

Education, Training and Experience

- Master's Degree in Audiology from a recognized program.
- At least two (2) years recent and relevant Post Masters clinical experience in the diagnostic assessment of infants including a minimum of one (1) year of extensive experience performing Auditory Brainstem Response and Otoacoustic Emissions testing specifically on infants that includes adjusting tests, determining abnormal test results, and interpreting pattern of results on complex cases to determine an accurate and clear audiological diagnosis.
- Eligible for certification with the Canadian Speech-Language Pathologists and Audiologists (CASLPA) or the British Columbia Association of Speech-Language Pathologists and Audiologists (BCASLPA) or equivalent.
- This position involves travel within and outside the Vancouver area; a car and valid BC Driver's license is required.

Skills and Abilities

- Comprehensive knowledge of theoretical and practical clinical audiology with an emphasis on infant diagnostic audiology assessment as it relates to the early detection of hearing loss.
- Knowledge of adult education principles, methods and tools.
- Knowledge of research methodology and processes.
- Demonstrated ability to develop training programs, manuals, instructional material, and evaluation tools.
- Demonstrated ability to function as an effective team member, leader, and facilitator.
