#### Job purpose

The Community Service-Dalhousie Hearing Aid Assistance Program (CS-DHAAP) at the School of Communication Sciences and Disorders, Dalhousie University, in partnership with the Department of Opportunities and Social Development (Nova Scotia Government), provides essential audiology diagnostic services, hearing aid fittings, and audiologic rehabilitation to clients receiving Income Assistance benefits.

We are currently accepting applications for a **Part-Time Temporary Audiologist** position. This position will be for a duration of **12 months**, starting **July 1, 2025**.

#### **Duties and responsibilities**

- Conduct audiology adult diagnostic assessments to determine hearing aid candidacy.
- Select, fit, and verify hearing aids using probe microphone measures in accordance with DHAAP protocols.
- Provide counselling and rehabilitative services post-hearing aid fitting.
- Measure and document treatment outcomes.
- Maintain patient records and complete clinical reports for referring sources and family physicians.
- Supervise and provide clinical education to SCSD graduate students.

#### Qualifications

Applicants must have a master's degree in Audiology, at least one year of clinical experience, and be eligible for or a current member of the Nova Scotia College of Audiologists and Speech Language Pathologists. Excellent communication, interpersonal, and organizational skills are required. Experience supervising graduate students is an asset.

## **Working conditions**

**On campus role:** Due to operational requirements, the successful applicant is required to work in-person on campus.
